



TRANSITION TO BPER DIGITAL SERVICES FOR YOUR COMPANY

From **20 April 2026**, as part of the integration between **Banca Popolare di Sondrio and BPER Banca**, the services currently available on **SCRIGNOmultibanca** will be replaced by the new BPER B:Digital Corporate.

The aim is to provide a simple, consistent experience aligned with your company's needs, offering new opportunities while ensuring service continuity, no interruptions, and full retention of your data.

What is B:Digital Corporate?

The new portal for companies with complex, multi-bank operations, designed to manage collections, payments, and information flows within a single platform.

What you will find:

- > Accounts of the parent company and any affiliates
- > Account balances and transactions
- > Account information and transaction history (excluding online transactions)
- > Existing users with their assigned profiles
- > Address book

What you can do:

- > Operate in a structured and flexible manner
- > Manage collections and payments even with multiple users and companies within the same group
- > Operate both online and via batch file processing
- > Work within defined roles, limits and approval rules

Useful information:

> If your company uses **SCRIGNOmultibanca** with more than one SIA code, **only one SIA code** can be used in **B:Digital Corporate**. Your branch is on hand to review your position and support you during the transition.

> If, before 20 April 2026:

- > **Your company already uses B:Digital Corporate or Smart CBI**, the SCRIGNOmultibanca service will be automatically deactivated. Your accounts with Banca Popolare di Sondrio (e.g. current accounts or securities accounts) will be transferred to BPER.
- > **One or more of your affiliates** (if any) included in the SCRIGNOmultibanca contract **already use B:Digital Corporate or Smart CBI**, they will not appear in your new B:Digital Corporate environment and will continue operating via their existing BPER channel.

In both cases, companies already using a BPER digital channel do not need to request new credentials and can continue using their existing BPER credentials. The SCRIGNOmultibanca transaction history will not be migrated.

> Users will be able to operate using the same profiles as in SCRIGNOmultibanca. From 20 April 2026, once new credentials have been issued, the Master User can access the "Management" menu in B:Digital Corporate to change the roles and operating limits of other users.

Do you also have SCRIGNOazienda?

If, in addition to SCRIGNOmultibanca, you also use **SCRIGNOazienda**, only the data and configurations from SCRIGNOmultibanca will be migrated to B:Digital Corporate. This will allow you to manage your operations and view documents from a single platform. If you have configured different users or added contacts in the address book within SCRIGNOazienda, we recommend setting them up in SCRIGNOmultibanca **by 16 April**, so they will already be available once you switch to B:Digital Corporate.

How do I log in for the first time?

From **20 April 2026**, to access the new B:Digital Corporate portal, you will need to **convert your existing SCRIGNOmultibanca login credentials**.

> Go to **bper.it**

> Click on **Account Login** on the top right

> Select **B:Digital Corporate – The new Corporate Banking**

> Enter your login credentials:

> **If you are an administrator:**

Contract Code: use your old **SCRIGNOmultibanca** "Customer Code"

> if your code starts with "W", replace it with "8" (e.g. W12345678 > 812345678)

> if your code starts with "WEB", replace it with "880" (e.g. WEB12345678 > 88012345678)

User Code: use the modified Contract Code

Password: use the same SCRIGNOmultibanca password

> **If you are a user:**

Contract Code: ask your Administrator for the code (it corresponds to their new User Code)

User Code and password: use the same credentials as SCRIGNOmultibanca

> After entering your credentials, you can confirm access in **one of the following ways:**

> with your **physical token** (if previously used)

> with the new **B:Digital Corporate app** (if you previously used the SCRIGNOmultibanca app)

You may switch from the physical token to app-based authentication at any time. After switching, the physical token will be deactivated.
